- 7. Property Tax Relief Grant
 - A. Leo—This is the second year we have applied for it. IT is additional dollars to give local property tax relief. It is very unlikely we will be awarded the grant but we apply to at least try and have a chance for extra funds.
 - B. Lori—How do they determine who is awarded the grant?
 - C. Leo—They start with Tier 1 applicants. We are tier 2. You do have to abate they money.
- 8. 2020-21 School Calendar
 - A. John—I've received no questions regarding the calendar. The District Calendar Committee met to create the calendar. They have also worked on next year's calendar; it will look similar to this one. It is good to get these out now to allow families to start planning events and vacations. I propose in the future to plan two years in advance but the Middle School build could impact a calendar.
- 9. Strategic Plan Update
 - A. John—I just thought it would be a good time to touch base on where we are with our Strategic Plana at the half year mark. On the other side of your sheet, the greatness indicators can be found. All goals on this page are new goals. A lot of goals say continue as we have started them and continue to work on them. The Greatness Indicators and Metrics are being worked on. We are accumulating first year baseline data. We may not get them all going this year but they are

being worked on. Security Committee will present in January. For the first time ever, we've created a District Leadership Team. They will report on goals. We formed a District Special Education committee to check effectiveness; meshing with the Macon-Piatt Special Education Group. We implemented an Art Program for grades K-8. We began a Finance/Facilities of the Board Committee which Leo heads. They are reviewing Fund 60 recommendations and Safety Team recommendations. We are working our Strategic Plan, keeping the District focused.

- 10. Joint Conference 2019 Reflections
 - A. John—I'd like for us to reflect on the 2019 Conference. Lori, Darin and I attended a session held by the Triad District on School Resource Officers. The message they really got across was how important it is the school has a voice in the hiring as not everyone is cut out to be a School Resource Officer.
 - B. Lindsey—I went to a round table session for School Board Presidents. All the schools were in the Chicago area so I couldn't really relate to the issues they are going though. While listening to their issues, I did feel good about what we're doing and that we've had success.

 - D. Brandi—The strategic communication session I went to went over and discussed a lot of things we're already doing.
