

## Maroa Forsyth School District Online Community Survey November/December 2019

## Overview of Data

In November/December 2019, UNICOM•ARC conducted an online survey of residents of the Maroa Forsyth service area. The purpose of the survey was to better understand area residents' perceptions of the district's facility improvement plan.

Five hundred forty-two (542) surveys were completed. Results were tabulated on December 2 2019.
