Three Circles grant

The Agriculture grant that we will continue to pursue. This will increase Cassie's stipend. The board wants to sit down with union leadership and Cassie to discuss bringing her up from 12% to 15% w/ a
MOU and bring back to the meeting in August.
3. Extra-curricular driver rate
Our previous rate was \$14.65 and we increased to \$15.38/ hour. We've had a hard time getting people to drive the extra-curricular buses. When compared to other school districts, the following was found:
AO- \$25/ hour guarantee minimum of 5 hours.
Gibson Clty- \$17/ hour guarantee minimum of 2 hours
Sang Valley- \$13.20/ hour guarantee minimum of 3 hours
Mt. Zion-\$17/ hour for new hire, \$17.50/ hour for existing, increasing \$1 per year up to 4 years.
Our board would like to offer \$18/ hour with no minimum.

5. Safety plans and updates
